The Real Estate Standards Organization (RESO) provides data standards and processes that create efficiencies for all participants in a real estate transaction. RESO's members include MLSs, brokerages, Realtor associations, and technology partners

First, they impact MLS field names.

RESO's goal is to establish a standard set of field names – a Dictionary – that can be used by everyone. For example, using Pending instead of Under Contract.

Second, RESO aims to ensure listing data is shared and delivered to partners, vendors, and business tools using more advanced technology.

When we're all speaking the same language and sharing data using up-to-date technology, existing business tools can be improved, and new tools can be developed faster and better. That's good for all of us!

Future Changes

ValleyMLS is committed to working with the RESO standards. Aligning with RESO's Data Dictionary to maintain standardized fields means listing information within Paragon can be easily transferred between different apps, servers, and systems, all speaking the same language. Being RESO certified is a significant advantage for ValleyMLS. It allows us to onboard innovative tools and products quickly and reliably, enhancing the overall technology experience for consumers and professionals.
